High Court of Chhattisgarh will remain closed for Winter Holidays from 21.12.2020 to 31.12.2020.

During the Winter Holidays only fresh Criminal Appeals, fresh Criminal Revisions, (pertaining to short sentences upto three months), fresh petitions under Section 438 & 439 of Cr.P.C. as per their chronological order, and those cases of urgent nature (be it a Writ, Civil or Criminal matter), accompanied by an application for urgent hearing and application for hearing during Winter Holidays, (except Writ Appeal matter) which are in order, filed and registered on or before 21.12.2020, will be listed for hearing on 23.12.2020. If any extreme urgent situation arises in Writ Appeal matter during the period of Winter Holidays, Division Bench may be constituted for the purpose.

Hon'ble Mr. Justice R.C.S. Samant has been nominated as Winter Holidays Judge to hold Court sitting on 23.12.2020 from 10.30 AM onwards for hearing of above mentioned cases.
