

The services of Shri Shivmangal Pandey, Retired District Judge, who was appointed to the post of Senior Faculty Member, Chhattisgarh State Judicial Academy, Bilaspur vide Registry Order No. 571/Confdl./2015/II-2-90/2001 (Pt.-III) dated 28.07.2015, are, hereby, extended for a period of one year w.e.f. 02.08.2018, consequent upon completion of tenure of service on the following terms and conditions:-

1. His tenure of service would be one year with effect from 02.08.2018.
2. His services shall be terminated at any time during the tenure of one year without notice and assigning any reason whatsoever.
3. During the tenure of his service he will be paid salary of District Judge (Selection Grade) as per the formula i.e. last pay minus pension. If the last pay exceeds Rs. 70,290/-, then the last pay shall be treated as Rs. 70,290/-.
4. During the period of service, he shall be entitled for allowances, facilities and amenities, which are available for a serving District & Sessions Judge (Selection Grade).


