

3. Bail Petitions U/s 439 Cr.P.C., specifically allotted to Hon'ble Single Bench comprising Hon'ble Mr. Justice P.P. Sahu vide notification dated 02.12.2020 shall be listed before Single Bench comprising **Hon'ble Mr. Justice Gautam Chourdiya.**


